Hereby, I would like to alert you that the European Internet Services Providers' Association lists lobby expenses of less than 10.000 Euros only. This sounds unrealistically low when you consider that according to the EuroISPA website there are at least three people at the association doing advocacy work towards the EU-institutions (<https://www.euroispa.org/about/who-we-are/#secretariat>).

We would welcome if you take note of this and ask EuroISPA to double-check the expenses they have listed in their transparency register entry.
